Explanation of Responses:

- Settlement of restricted stock units ("RSUs"). On December 21, 2012, the reporting person was granted 7,500 RSUs, vesting in two installments as follows: 3,750 on June 30, 2013 and 3,750 on December 15, 2014. Each RSU represents a contingent right to receive one share of Allison Transmission Holdings, Inc. ("ALSN") common stock.
- Represents shares withheld by ALSN to satisfy tax withholding obligations on the vesting of RSUs.
- Settlement of dividend equivalent rights ("DERs"). The DERs accrued when and as dividends were paid on ALSN common stock and vest proportionately with the RSU to which they relate. Each DER is the economic equivalent of one share of ALSN common stock.
- Represents shares withheld by ALSN to satisfy tax withholding obligations on the vesting of DERs.
